What is Workplace Giving and how does it work?

Workplace Giving is an easy and effective way to make regular donations to ActionAid Australia through payroll deductions.

Donations are made automatically from your pre-tax pay, which means you instantly receive a tax deduction each pay cycle!

You can start or change your donation at any time.

What are the benefits?

For employees

You receive an immediate tax benefit from your pre-tax donation. For example, if you make a monthly donation of \$40 to ActionAid Australia:

- You receive an immediate tax saving of \$13*, so the net cost to you is \$27;
- You will also receive regular updates on how your donation is making a difference;
- If your employer matches your donation, \$80 will go towards helping women claim their rights and fight poverty and injustice.
