4. Principal activities

The principal activities of the Company in the course of the financial year were to conduct co-ordinated appeals and projects in the cause of people affected by conflict and natural disaster and to build human security for those people.

During the 2008 financial year, Austcare continued to provide humanitarian assistance and support to projects with a long-term development impact in partnership with various national and international NGOs, government departments and tertiary institutions.

5. Operating and financial review

Austcare's total income for the year was \$8,445,190 (2007 - \$6,867,931) and total disbursements were \$9,731,598 (2007 - \$8,221,648), resulting in an overall deficit for the year of \$1,286,408 (2007 - \$1,353,717). Included in disbursements was \$7,778,811 (2007 - \$6,637,235) to projects, community education and advocacy. Total undistributed funds as at 30 June 2008 were \$1,307,082 (2007 - \$2,593,490) and cash balances \$4,295,088 (2007 - \$4,912,569).

Austcare provided funds to support people affected by conflict and natural disaster in Africa, the Middle East and Asia Pacific, as well as community education activities in Australia. Public funds raised by Austcare amounted to \$2,077,834 (2007 - \$2,316,244). AusAID and other grant income was \$6,250,354 (2007 - \$4,353,879) which excludes grants not yet disbursed which have been treated as a liability and amounted to \$4,135,126 (2007 - \$2,617,730).

Significant changes in the state of affairs

In the opinion of the directors there are no significant changes in the state of the affairs of the Company that occurred during the financial year under review.

6. Events subsequent to reporting date

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors of the Company, to affect significantly the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

7. Likely developments

The directors believe that the needs of people affected by conflict and natural disaster and the need to build human security for those people will not diminish in the foreseeable future. The directors and management will continue to work towards meeting those needs.

Austcare joined the ActionAid global network as its Australian Associate in September 2007, with a commitment by both agencies to continue to work closely with poor and excluded communities and to become an Affiliate of the ActionAid network in 2009. Upon affiliation, Austcare will change its name to reflect its new Affiliate status; however Austcare will retain its Board of Directors in Australia, and will have representation within ActionAid International's governance arrangements. Becoming part of the ActionAid network will greatly enhance Austcare's ability to respond to emergencies, and outreach its experience in protection, mine action and the prevention and reduction of armed violence.

ActionAid is an international anti-poverty organisation with a vision of a world without poverty in which every person can exercise their right to a life of dignity. ActionAid was formed in 1972 and now helps over 13 million of the world's poorest and most disadvantaged people in 42 countries worldwide.

8. Indemnification and insurance of officers and auditors

Indemnification

The Company has taken out a directors' and officers' insurance policy to indemnify all the present and past directors and officers of the Company to another person (other than the Company) that may arise from their position as directors and officers of the Company, except where the liability arises out of conduct involving a lack of good faith. No claims were made during or since the financial year and there are no outstanding claims.

Insurance premiums

The directors have not included details of the nature of the liabilities covered or the amount of the premium paid in respect of the directors' and officers' liability and legal expenses insurance contracts, as such disclosure is prohibited under the terms of the contract.

1 Reporting entity

Austcare (the "Company") is a Company incorporated and domiciled in Australia as a Company limited by guarantee. In accordance with the constitution of the Company, every member of the Company undertakes to contribute an amount limited to \$50 per member in the event of the winding up of the Company.

The Company is primarily involved in poverty alleviation and addressing the needs of refugees and displaced people.

2 Basis of preparation

(a) Statement of compliance

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards (AASBs) (including Australian Accounting Interpretations) adopted by the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The financial report of the Company also complies with the IFRSs and interpretations adopted by the International Accounting Standards Board.

The financial statements were approved by the Board of Directors on 2 October 2008.

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

(c) Functional and presentation currency

The financial statements are presented in Australian dollars, which is the Company's functional currency.

(d) Use of estimates and judgements

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

3 Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in the financial statements.

(a) Foreign currency

Transactions in foreign currencies are translated at the foreign exchange rate ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies at the balance sheet date are translated to Australian dollars at the foreign exchange rate ruling at that date. Foreign exchange differences arising on translation are recognised in the income statement.

(b) Property, plant and equipment

(i) Owned assets

Items of property plant and equipment are stated at cost or deemed cost less accumulated depreciation (see below) and impairment losses (see accounting policy (c)). Where parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items of property, plant and equipment.

(ii) Depreciation

Depreciation is charged to the income statement on a diminishing value basis for all depreciable assets except computer equipment, software and buildings, which are depreciated on a straight line basis over their estimated useful lives. Land is not depreciated. Depreciation rates applied range from 2.5% for buildings to 33% for computer software.

(c) Impairment

The carrying amounts of the entity's assets are reviewed at each balance sheet date to determine whether there is any indication of impairment. If any such indication exists, the asset's recoverable amount is estimated.

An impairment loss is recognised whenever the carrying amount of an asset or its cash generating unit exceeds its recoverable amount. Impairment losses are recognised in the income statement unless an asset has previously been re-valued, in which case the impairment loss is recognised as a reversal to the extent of the previous revaluation with any excess recognised through profit and loss.

The recoverable amount is the greater of fair value less costs to sell and value in use.

Calculation of recoverable amount

The recoverable amount of the Company's receivables carried at amortised cost is calculated as the present value of estimated future cash flows, discounted at the original effective interest rate (i.e., the effective interest rate computed at initial recognition of these financial assets). Receivables with a short duration are not discounted.

(c) Impairment (continued)

Impairment of receivables is not recognised until objective evidence is available that a loss event has occurred. Significant receivables are individually assessed for impairment. Impairment testing of significant receivables that are not assessed as impaired individually is performed by placing them into portfolios of significant receivables with similar risk profiles and undertaking a collective assessment of impairment. Non-significant receivables are not individually assessed. Instead, impairment testing is performed by placing non-significant receivables in portfolios of similar risk profiles, based on objective evidence from historical experience adjusted for any effects of conditions existing at each balance sheet date.

The recoverable amount of the Company's other assets is the greater of their net selling price and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. For an asset that does not generate largely independent cash inflows, the recoverable amount is determined for the cash-generating unit to which the asset belongs.

Reversals of impairment

An impairment loss in respect of a receivable carried at amortised cost is reversed if the subsequent increase in recoverable amount can be related objectively to an event occurring after the impairment loss was recognised.

An impairment loss in respect of other assets is reversed if there has been a change on the estimates used to determine the recoverable amount.

An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation, net of depreciation or amortisation, if no impairment loss had been recognised.

(d) Employee Benefits

(i) Defined contribution superannuation funds

Obligations for contributions to defined contribution superannuation funds are recognised as an expense in the income statement as incurred.

(ii) Long-term service benefits

The Company's net obligation in respect of long-term service benefits is the amount of future benefit that employees have earned in return for their service in the current and prior periods. The obligation is calculated using expected future increases in wage and salary rates including related on-costs and expected settlement dates, and is discounted using the rates attached to the Commonwealth Government bonds at the balance sheet date which have maturity dates approximating to the terms of the entity's obligations.

(iii) Wages, salaries, annual leave, sick leave and non-monetary benefits

Liabilities for employee benefits for wages, salaries and annual leave that are expected to be settled within 12 months of the reporting date represent present obligations resulting from employees' services provided to reporting date, are calculated at undiscounted amounts based on remuneration wage and salary rates that the entity expects to pay as at reporting date including related on-costs, such as workers compensation insurance.

(e) Revenue recognition

Appeals and donations

Austcare is a non-profit organisation and receives significant income from donations. These amounts by their nature can only be recognised when they are recorded in the books of Austcare. Donations are recorded as income when they are received.

AusAID & Other Government Grants

The Company receives Federal and State Government funding for various programs. Grant income is recognised when there is a non-reciprocal transfer, as required in AASB 1004. A non-reciprocal transfer of grants occurs only when the obligations set out in the grant agreement have been met. Funds received in advance of obligations being met are deferred and taken to income as the related expenses are incurred and obligations are met.

Interest revenue

Interest is recognised as it is accrued, taking into account the effective yield on financial assets.

Volunteer & In-kind Contributions

The value of services provided by volunteers during the financial year is \$28,360 (2007 - \$17,952). The value of these services has been calculated in accordance with AusAID guidelines. In-kind contributions of assets and contributions to assist in the acquisition of assets, being non-reciprocal transfers, is calculated by reference to the fair value of the assets received when the Company gains control of the contribution. There were no in-kind contribution of assets (2007 - \$nil).

The above amounts have not been included in the results of Austcare as the related transaction would be recorded as revenue and a disbursement in the same financial year and therefore the transaction has no effect on the results of Austcare.

(f) Income tax

The Company is a registered charity and is exempt from income tax under s50-5 of the Income Tax Assessment Act 1997.

(g) Goods and Services Tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

(h) Classification of expenses

Expenses have been classified in accordance with the format specified in the ACFID Code of Conduct for Non-Government Development Organisations.

(i) Reserves

Restricted Funds Reserve

Donations received for a specific purpose not yet disbursed for that purpose are transferred to Restricted Reserves, net of collection costs. Disbursements made to projects from restricted funds collected in prior periods are transferred out of reserves. The net transfer to/from restricted reserves is shown on the Income Statement. The gross transfers to/from restricted reserves are disclosed in note 8.

Unrestricted Funds Reserve

The Directors may decide to transfer surplus legacies and bequests and other donations received for the general work of Austcare to unrestricted funds reserve. The net transfer to/from unrestricted reserves is shown on the Income Statement. The gross transfers to/from restricted reserves are disclosed in note 9.

(j) Segment reporting

A segment is a distinguishable component of the Company that is engaged either in providing products or services (business segment), or in providing products or services within a particular economic environment (geographical segment), which is subject to risks and rewards that are different from those of other segments.

(k) Trade and other payables

Trade and other payables are stated at cost.

(l) Trade and other receivables

Trade and other receivables are stated at their cost less impairment losses (see accounting policy (c)).

(m) Cash and cash equivalents

Cash and cash equivalents comprise cash balances and are carried at fair value of the amounts deposited.

(n) Net financing costs

Interest revenue is recognised in the income statement as it accrues, using the effective interest method, net of any withholding tax.

(o) New standards and interpretations not yet adopted

The following standards, amendments to standards and interpretations have been identified as those which may impact the entity in the period of initial application. They are available for early adoption at 30 June 2008, but have not been applied in preparing this financial report:

Revised AASB 101 *Presentation of Financial Statements* introduces as a financial statement (formerly "primary" statement) the "statement of comprehensive income". The revised standard does not change the recognition, measurement or disclosure of transactions and events that are required by other AASBs. The revised AASB 101 will become mandatory for the Group's 30 June 2010 financial statements. The Group has not yet determined the potential effect of the revised standard on the Group's disclosures.

Other transactions with the Company

Trevor Fearnley holds a position in AdPartners Group Pty Ltd, which results in him having considerable influence over that entity. AdPartners Group Pty Ltd is the major supplier of fundraising services to the Company. The terms and conditions of these transactions were more favourable to Austcare than those available, or which might reasonably expect to be available, on similar transactions to non-director related entities on an arm's length basis.

Purchases from AdPartners Group by the Company during the financial year totalled \$150,750 (2007 \$180,430), and at year end the amount payable to AdPartners Group was \$7,939 (2007 \$3,025). AdPartners Group has estimated the commercial value of these transactions to be \$168,200 (2007 \$220,415).

No director has entered into a material contract with the Company since the end of the previous year and there were no material contracts involving directors' interests subsisting at year-end.

Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as and when they fall due. The Company's approach to managing liquidity is to ensure, as far as possible, that it will always have sufficient liquidity to meet its liabilities when due, under both normal and stressed conditions, without incurring unacceptable losses and risking damage to the Company's reputation.

The Company monitors cash flow requirements and optimises its cash return on investments. Typically the Company ensures that it has sufficient cash on demand to meet expected operational expenses for a period of at least 60 days, excluding potential impact of extreme circumstances that cannot be reasonably predicted, such as natural disasters.

The Company has no borrowings. The total financial liability consists of trade and other payables of \$4,515,851 (2007: \$2,986,553). This includes \$3,908,672 of Australian government grants not yet spent (2007: \$2,543,271) and \$226,454 of other grants not yet spent (2007: \$74,459). All trade and other payables are settled within 6 months or less, with the exception of grants not yet spent that are spent over the duration of individual projects.

Currency risk

The Company is exposed to currency risk on program expenses that are denominated in a currency other than the Australian Dollar (AUD); however agreements with implementing partners are denominated in the same currency as donor agreements to minimise the currency risk. The Company is also exposed to currency risk on cash and financial instruments that are held in the Company's offices in Timor Leste, Palestine, Cambodia and Indonesia.

Cash balances and cash investments totalling \$4,295,088 (2007 - \$4,912,569) are subject to floating interest rates and fixed rates for periods not exceeding 90 days. The weighted average interest rate at balance date was 5.4% pa (2007 - less than 6.0%). Of this amount \$71,621 (2007 - \$53,351) was not interest bearing.

Financial liabilities



Independent Auditors' Report to the Members of Austcare

We have audited the accompanying financial report of Austcare ("the Company"), which comprises the balance sheet as at 30 June 2008, and the income statement, statement of changes in equity and cash flow statement for the year ended on that date, a summary of significant accounting policies and other explanatory notes 1 to 25 and the directors' declaration set out on page 29.

Directors' responsibility for the financial report

The directors of the Company are responsible for the preparation and fair presentation of the financial report in accordance with Australian Accounting Standards (including the Australian Accounting Interpretations) and the Corporations Act 2001. This responsibility includes establishing and maintaining internal control relevant to the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's responsibility

Our responsibility is to express an opinion on the financial report based on our audit. We conducted our audit in accordance with Australian Auditing Standards. These Auditing Standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the directors, as well as evaluating the overall presentation of the financial report.

We performed the procedures to assess whether in all material respects the financial report presents fairly, in accordance with the Corporations Act 2001 and Australian Accounting Standards (including the Australia Accounting Interpretations), a view which is consistent with our understanding of the Company's financial position, and of its performance.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Additional scope pursuant to the Charitable Fundraising (NSW) Act 1991

In addition, our audit report has also been prepared for the members of the Company in accordance with Section 24(2) of the Charitable Fundraising (NSW) Act 1991 and the requirements set out in the AusAID Head Agreement between the Commonwealth of Australia and Austcare (the AusAID Head Agreement). Accordingly we have performed additional work beyond that which is performed in our capacity as auditors pursuant to the Corporations Act 2001. These additional procedures included obtaining an understanding of the internal control structure for fundraising appeal activities and examination, on a test basis, of evidence supporting compliance with the accounting and associated record keeping requirements for fundraising appeal activities pursuant to the Charitable Fundraising (NSW) Act 1991 and Regulations; and the examination of four Activities funded under the AusAID Head Agreement.

It should be noted that the accounting records and data relied upon for reporting on fundraising appeal activities are not continuously audited and do not necessarily reflect after the event accounting adjustments and the normal year end financial adjustments for such matters as accruals, prepayments, provisioning and valuations necessary for year end financial report preparation.

The performance of our statutory audit included a review of internal controls for the purpose of determining the appropriate audit procedures to enable an opinion to be expressed on the financial report.
